1 General provisions

1.1 These Regulations for admission to master's and doctoral programs at the Kazakh National Research Technical University named after K.I. Satpayev (hereinafter referred to as the Rules) were developed in accordance with the Standard Rules for admission to training in educational organizations implementing educational programs of higher and postgraduate education, approved by Order of the Minister of Education and Science of the Republic of Kazakhstan of October 31, 2018 No. 600.

1.2 Admission of graduate and doctoral students to the Kazakh National Research Technical University (hereinafter referred to as KazNRTU or the University) is carried out by placing a state educational order for training personnel in scientific, pedagogical and specialized areas, as well as tuition fees at the expense of students' own funds and other sources.

2 Normative references

In these Rules, references to the following regulatory documents are used:

- 2.1 The Law of the Republic of Kazakhstan "On Education" of July 27, 2007, No. 319-III;
- 2.2 Typical rules for admission to training in educational organizations that implement educational programs of postgraduate education, approved by Order of the Minister of Education and Science of the Republic of Kazakhstan of October 31, 2018 No. 600.

3 The order of submission of documents for graduate and doctoral programs at KazNRTU

3.1 Admission to the master's and doctoral programs of KazNRTU, including targeted training, is carried out on a competitive basis based on the results of comprehensive testing (hereinafter referred to as CT) or entrance exams.

- 3.2 Admission of foreign citizens to master's and doctoral programs is carried out on a paid basis. Free postgraduate education for foreigners is accomplished on a competitive basis in accordance with the state educational order limited by international treaties of the Republic of Kazakhstan, with the exception of the scholarship program for master's degree programs.
- 3.3 Admission of foreign citizens to study at KazNRTU on a paid basis is carried out according to the results of an interview conducted by the admission

commissions of KazNRTU during the calendar year. Enrollment of foreign citizens is carried out in accordance with the academic calendar 5 (five) days before the start of the next academic period.

3.4 Education documents issued by foreign educational organizations are recognized in the manner prescribed by law.

Documents in a foreign language are provided with a notarized translation into Kazakh or Russian.

Educational documents issued by foreign educational organizations go through the procedure for recognizing educational documents in the manner prescribed by the legislation of the Republic of Kazakhstan after enrolling persons within 1 (first) academic period of study.

3.5 An admissions committee is being created to receive documents and organize entrance exams to KazNRTU. The Chairman of the admissions Committee is the Rector.

The composition and functions of the admissions committee are approved by the Rector's order.

- 3.6 For applicants for doctoral studies, the selection committee carries out:
- 1) advising applicants on the issues of the chosen group of educational programs of postgraduate education, familiarization with the procedure of the entrance examination;
 - 2) organization of reception and verification of documents of applicants;
- 3) organization of the entrance examination by groups of educational programs.
- 3.7 For applicants to the master's program, the admissions committee advises applicants on the issues of the selected group of educational programs of postgraduate education, as well as familiarization with the CT procedure.
- 3.8 Application submission to graduate programs at KazNRTU is carried out by the admission commissions of KazNRTU and (or) through the information system in the following terms:
 - 1) from July 3 to August 3 of the calendar year;
 - 2) from 1 to 15 November of the calendar year.
- CT for admission to the master's program is carried out in the following terms:
 - 1) From July 20 to August 10 of the calendar year;
 - 2) from November 18 to December 11 of the calendar year.
- 3.9 Submission of applications to the doctoral programs of KazNRTU is carried out by the admissions committees of KazNRTU and (or) through the NTC information system in the following terms:
 - 1) from July 3 to August 3 of the calendar year;
 - 2) from November 1 to November 15 of the calendar year.

Entrance exams for educational programs for doctoral studies are held from November 18 to December 11, 2021 on the basis of Regional Testing Centers (hereinafter referred to as RCTs) on computer format.

3.11 Upon admission to the master's and doctoral programs, in case of a discrepancy between the profile of the master's and PhD's educational program and the educational program of higher education, the prerequisites for mastering are set for the applicant. Applicants are allowed to master them on a paid basis according to the basic program of postgraduate education until the end of the first year of study, which is additionally included in the individual curriculum of the student.

As prerequisites, the graduate/doctoral student presents the results of nonformal education of the appropriate level, the recognition of which is carried out by the university in accordance with subparagraph 38-3) of Article 5 of the Law.

3.12 In applying for a PhD doctoral program, the educational program of the scientific and pedagogical magistracy is additionally set as prerequisites to a Master of a Specialized Programm.

Reception of application for magistracy and complex testing of entrants

4.1 Applicants who have mastered educational programs of higher education are admitted to the magistracy of KazNRTU.

- 4.2 Applicants, who enter the magistracy in the period from 25 to 28 August, from 26 December to 10 January of the calendar year submit a package of documents provided for in clause 8 of the State Service Standard "Acceptance of documents and enrollment in the organization of higher and (or) postgraduate education for training in educational programs of postgraduate education", in accordance with Appendix 1 to these Rules to the University (through the Admissions Committee of KazNRTU) (hereinafter referred to as the Admissions Committee) or through the web portal of "electronic government" www.egov.kz (hereinafter referred to as the Portal).
- 4.3 The list of basic requirements for the public service provision, including the characteristics of the process, the form, content and result of service provisions, as well as other information, taking into account the specifics of public services provisions, is given in the Standard of Public Services.

Information about identity documents, higher education document, medical certificate is provided to the University from the relevant state information systems through the "electronic government" gateway.

An employee of the Admissions Committee accepts a package of documents, their registration and issuance of a receipt to an applicant for the acceptance of a package of documents, in the form approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated January 28, 2015 No. 39 "On approval of types and forms of education documents of the state standard and Rules their issuance "(registered in the Register of State Registration of Normative Legal Acts under No. 10348) on the day of receipt of the application or, if the applicant provides an incomplete package of documents, refuses to accept the documents.

In the case of an application through the portal, the status of acceptance of the request for a public service, as well as a notification indicating the date and time of receipt of the result of the public service is sent to the "personal account" of the applicant.

The University, from the moment of their receipt, checks the completeness of

the submitted documents, in case of incompleteness, prepares a reasoned refusal to further consideration of the application and sends it in the form of an electronic document to the "personal account" on the portal to the applicant.

In the event that an applicant provides a full package of documents, a notification is sent to the University about the acceptance of documents for enrollment of a master's student. After receiving the notification, the applicant submits the original documents to the University by August 28 of the calendar year.

After receiving the original documents, an order on the admission of the applicant to the number of undergraduates is ussued by the Rector of KazNRTU.

The University refuses to provide public services on the basis of paragraph 9 of the Public Service Standard.

The Service Provider provides information about the stage of rendering a public service into the information system for monitoring public service provisions in accordance with subparagraph 11) of paragraph 2 of Article 5 of the Law of the Republic of Kazakhstan dated April 15, 2013 "On Public Services".

A complaint about the decision, actions (inaction) of the service provider on the provision of public services can be filed in the name of the head of the service provider, to the authorized body for assessing and monitoring the quality of the provision of public services, in accordance with the legislation of the Republic of Kazakhstan.

The service recipient's complaint received by the service provider, in accordance with paragraph 2 of Article 25 of the Law, is subject to consideration within 5 (five) business days from the date of its registration.

The service recipient's complaint received by the authorized body for the assessment and control over the quality of the provision of public services is subject to consideration within 15 (fifteen) business days from the date of its registration.

In cases of disagreement with the results of the provision of public services, the service recipient applies to the court in the manner prescribed by the legislation of the Republic of Kazakhstan.

4.4. Applicants, entering the profile magistracy with the Kazakh or Russian language of instruction at KazNRTU pass CT (complex testing), which includes a test on the profile of groups of educational programs, a test to determine readiness to study in Kazakh or Russian by choice.

Applicants, entering the scientific and pedagogical magistracy with the Kazakh or Russian language of instruction at KazNRTU, pass CT (complex testing), including a foreign language test, a profile of groups of educational programs test and a test to determine readiness to study in Kazakh or Russian by choice.

4.5 CT (Complex testing) is carried out in accordance with the Rules for Complex Testing, approved by order of the Minister of Education and Science of the Republic of Kazakhstan dated May 8, 2019 No. 190 (registered in the Register of State Registration of Normative Legal Acts under No. 18657).

CT (Complex testing) is carried out by the National Testing Center of the Ministry of Education and Science of the Republic of Kazakhstan (hereinafter - NTC) at the places for CT (complex testing), determined by the Ministry of Education and Science of the Republic of Kazakhstan (hereinafter - MES RK).

Based on the results of CT, an electronic certificate is issued, which is

confirmed on the website of the National Testing Center of the Ministry of Education and Science of the Republic of Kazakhstan.

To retake the CT (complex testing) in the year of delivery is not allowed.

- 4.6 Applicants who have one of the international certificates confirming their proficiency in English in accordance with the common European competences (standards) of proficiency in English are exempted from the CT (Complex testing) English test for magistracy:
- International English Language Tests System (IELTS- Academic, threshold score at least 6.0),
- Test of English as a Foreign Language Institutional Testing Programm (TOEFL IBT, threshold at least 60),
- Test of English as a Foreign Language paper-based testing, (TOEFL PBT, threshold not less than 498;

Applicants entering the magistracy for the groups of educational programs in the areas of education "Natural Sciences, Mathematics and Statistics", "Information and Communication Technologies", "Engineering, Manufacturing and Construction Industries", as well as the areas of training "Business and Management" are exempt from CT in master's degree with Kazakh or Russian languages of studying in the presence of an international certificate of passing the standardized test Graduate Record Examinations (graduate record examination) GRE with scores in accordance with Appendix 2 to these Rules.

Applicants entering the magistracy "Business and Management" are exempt from CT (complex testing) with Kazakh, Russian or English languages of studying magistracy in the presence of an international certificate of passing the standardized test Graduate Management Admission Test (Graduate management administration test) GMAT with scores in accordance with Appendix 3 to these Rules.

When submitting documents for participation in the competition for the award of an educational grant, as well as when enrolling in the University, the authenticity and validity of the submitted certificates are checked by the Admissions Committee.

Applicants who have one of the certificates of passing the English language test specified in this paragraph, when submitting an application for participation in the competition for the award of an educational grant at the expense of the republican budget or local budget, as well as when enrolling in KazNRTU on a paid basis, 50 points are counted.

Applicants who have completed foreign EPHPE (Educational Programs of Higher and (or) Postgraduate Education) in countries whose state or official language is English and which have specialized accreditation of foreign Accreditation Bodies included in the registers and (or) Associations of Accreditation Bodiess of member states of the Organization for Economic Cooperation and Development (OECD) are exempt from block of testing "Foreign language" (English) CT for magistracy with Kazakh or Russian language of instruction.

4.7 To participate in the competition for the award of an educational grant of postgraduate education, an applicant, before August 20, submits an application to the admissions office of the EPHPE (educational programs of higher and (or) postgraduate education) or through the information system on a standard form.

Applicants to the master's degree in the application indicate one group of educational programs and up to 3 (three) EPHPE (educational programs of higher and (or) postgraduate education)

CT (complex testing) results are announced on the day they are performed.

- 5 Admission and entrance examinations for doctoral studies
- 5.1 Apllicants with a Master's degree and work experience of at least 9 (nine) months are admitted to doctoral studies.
- 5.2 Applicants entering doctoral studies, in the period from 22 to 28 August of the calendar year, submit to the Admissions Committee and (or) through the portal a package of documents provided for in clause 8 of the Public Service Standard, in accordance with Appendix 1 to these Rules.

KazNRTU accepts a package of documents, their registration in the information system of the National Testing Center (hereinafter referred to as NTC) and issues a receipt to the applicant for receiving the package of documents on the day of receipt of application, or, if the applicant provides an incomplete package of documents, refuses to accept the documents.

The service provider's employee accepts a package of documents, their registration and issuance of a receipt to the service recipient for receiving the package of documents on the day of receipt of the application, or, if the service recipient provides an incomplete package of documents, refuses to accept the documents.

When submitting documents to the EPHPE (educational programs of higher and (or) postgraduate education), the applicant chooses 1 EPHPE and 1 GEP (Group of educational Program) for admission.

The list of basic requirements for the public service provision, including the characteristics of the process, the form, content and result of service provisions, as well as other information, taking into account the specifics of public services provisions, is given in the Standard of Public Services.

Information about identity documents, higher education document, medical certificate is provided to the University from the relevant state information systems through the "electronic government" gateway.

An employee of the Admissions Committee accepts a package of documents, their registration and issuance of a receipt to an applicant for the acceptance of a package of documents on the day of receipt of the application or, if the applicant provides an incomplete package of documents, refuses to accept the documents.

In the case of an application through the portal, the status of acceptance of the request for a public service, as well as a notification indicating the date and time of receipt of the result of the public service is sent to the "personal account" of the applicant.

Admissions committee from the moment of their receipt, checks the completeness of the submitted documents, in case of incompleteness, prepares a reasoned refusal to further consideration of the application and sends it in the form of an electronic document to the "personal account" on the portal to the applicant.

In the event that an applicant provides a full package of documents, a notification is sent to the University about the acceptance of documents for enrollment of a doctorial student. After receiving the notification, the applicant submits the original documents to the University by August 28 of the calendar year.

After receiving the original documents, an order on the admission of the applicant to the number of doctorial students is ussued by the Rector of KazNRTU.

The University refuses to provide public services on the basis of paragraph 9 of the Public Service Standard.

- 5.3 The Service Provider provides information about the stage of rendering a public service into the information system for monitoring public service provisions in accordance with subparagraph 11) of paragraph 2 of Article 5 of the Law of the Republic of Kazakhstan dated April 15, 2013 "On Public Services".
- 5.4.A complaint about the decision, actions (inaction) of the service provider on the provision of public services can be filed in the name of the head of the service provider, to the authorized body for assessing and monitoring the quality of the provision of public services, in accordance with the legislation of the Republic of Kazakhstan.
- The service recipient's complaint received by the service provider, in accordance with paragraph 2 of Article 25 of the Law, is subject to consideration within 5 (five) business days from the date of its registration.

The service recipient's complaint received by the authorized body for the assessment and control over the quality of the provision of public services is subject to consideration within 15 (fifteen) business days from the date of its registration.

In cases of disagreement with the results of the provision of public services, the service recipient applies to the court in the manner prescribed by the legislation of the Republic of Kazakhstan.

- 5.5 Reception of applications (in arbitrary form) or persons applying for training under a state educational order as part of targeted training in groups of doctoral studies is carried out at Satbayev University.
- 5.6 Applicants to doctoral studies provide international certificates confirming English language proficiency in accordance with the common European competences (standards) of English language proficiency:
- IELTS Academic / International English Language Tests System, Academic, passing score minimum 5.5;
- Test of English as a Foreign Language Institutional Testing Programm Internet-based Test (TOEFL IBT), passing score-minimum 46;
- Test of English as a Foreign Language Paper-based testing (TOEFL PBT) passing score minimum 453.

The authenticity and validity of the certificates provided are checked by the Admissions Committee.

Persons who have completed a foreign Organization of Higher and Postgraduate Education in countries whose official language is English and have specialized accreditation of foreign accreditation bodies

Those included in the registers and (or) associations of accreditation bodies of the member States of the Organization for Economic Cooperation and Development (OECD) do not provide international certificates confirming foreign language proficiency in accordance with the pan-European competencies (standards) of foreign language proficiency specified in this paragraph for 5 years.

5.7 The entrance examination to the doctoral studies is conducted in a computer format.

The entrance examination in computer format for groups of doctoral studies according to Appendix 4 is conducted in organizations designated by the authorized body in the field of education.

The entrance examination to the doctoral studies in a computer format consists of:

- 1) writing an essay;
- 2) the test of ready for training for doctoral studies;
- 3) answers to examination questions on the profile of the group of the educational program.

When passing the entrance examination, the entrant independently chooses the order of the answer according to the blocks.

Entrants' answers are encoded and sent to the Organization of Higher and Postgraduate Education on the day of the entrance examination.

To monitor compliance with the rules of the entrance exam, the administrators of the entrance exams are sent to the Regional Testing Center, who perform the functions of a duty officer in the audience and along the corridor.

Applicants are started for the entrance exam upon presentation of the original identity document (identity card or passport), while the identity of the incoming person is identified through a Face ID.

At the launch to the exam used metal detectors manual and frame type. The use of metal detectors at the entrance exam is carried out within the security of entering the entrance exam, as well as preventing them from attempting and sneaking into the building of prohibited items cheat sheets, educational and methodological literature, calculator, camera, mobile communications, equipped with the functions of the information transfer: cell phones, tablets, iPad, iPod, SmartPhone, laptops, players, modems, use any kind of radio electronic communications: Wi-Fi, Bluetooth, Dect, 3G, 4G, 5G, smart watches, wire and wireless headphones and other.

If prohibited items are detected when checking with a metal detector during the launch of the entrance exam, the administrator of the entrance exam, together with observers, draws up an Act and the applicant is not allowed to take the entrance exam.

If a "front person" is identified during the launch of the entrance computer based exam, the administrator of the entrance exam in the presence of a front person draws up an "Act of identifying a front person during the launch of the entrance exam".

Applicants who have involved "front person" are not allowed to take the entrance exam.

During the entrance exam, the applicant is not allowed to:

leave the classroom (computer class) without the permission and accompaniment of the entrance exam administrator, who performs the functions of a corridor attendant;

- leave the classroom (computer class) during the first and last hours of the entrance exam. At the same time, you can leave the audience for no more than 10 minutes, no more than 2 times;
- to talk, to move from place to place;
- exchange A4 documents and papers issued to the applicant;
- take out A4 documents and papers of the classroom (computer class) issued to the applicant for work;
- bring into the classroom (computer class) and use cribs, educational and methodological literature, calculator, camera, mobile communications (pager, cell phones, tablets, iPads, iPods, SmartPhone, laptops, music players, modems (mobile routers), use any type of radio electronic communications (Wi-Fi, Bluetooth, Dect, 3G, 4G, 5G, smart watches, headphones wired and wireless, and so on);
- make noise before or during the entrance examination;
- to take with you the A4 paper issued before the beginning of the entrance examination;
- discuss and disclose the content of test assignments and exam questions;
- Intentionally damaging the equipment for the use of testing and security system.

At the same time, it is allowed to use a calculator, periodic tables and solubility of salts which is available in the computer interface for testing.

If the entrant violates the above points, the administrator of the entrance examination together with the observers shall prepare an "Act of detection of prohibited items" and removal from the audience of the entrant who violated the rules of conduct in the auditorium.

In the case of detection of an unauthorized person in the exam conducted in computer format, the administrator of the entrance examination in the presence of an unauthorized person shall prepare an "Act of detection of an unauthorized person in the process of the entrance examination". The unauthorized person will be removed from the auditorium. The results of the entrance examination will not be processed and will be subjected to cancellation.

Persons, who involved in the entrance examination "unauthorized persons" are not allowed to the entrance exam.

The final score is a set of points obtained by summing the results of the evaluation of the essay, the test of readiness for PhD studies, the answer to the examination questions on the profile of the educational program group in accordance with Appendix 5.

Types and evaluation criteria of the essay, as well as the structure and content and evaluation criteria of the exam on the profile of the Group of Educational Programs are attached in accordance with Appendix 6.

The entrance examination to the PhD program takes 4 hours.

- 5.8 The University approves the essay topics, questions on the profile of the group of the educational program two months before the start of the entrance exams and places the essay topics, questions on the profile of the group of the educational program approved by the collegial governing body on the official website of the University.
- 5.9 For the period of the entrance examinations for doctoral studies, examination commissions for groups of educational programs are created at Satbayev University. It is allowed to create one examination commission in related areas of training.
- 5.10 Examination Commissions for groups of educational programmes are formed from the teaching staff and employees of Satbayev University who have a degree of doctor or candidate of sciences, or doctor of philosophy (PhD) in the relevant profile.

The examination commission does not include members of the appeals commission.

The composition of examination commissions with an indication of their chairpersons shall be approved by order of the Rector and sent to the authorized body in the field of education.

The applicant fills out a questionnaire indicating his/her surname, first name and patronymic (if any), Organization of Higher and Postgraduate Education (Satbayev University) and Group of Educational Programs and proceeds to write an essay, take the Doctoral Readiness Test, answer the examination questions on the profile of the educational programme group selected at random in writing and send the results to Satbayev University). The results of the readiness test are processed by National Testing Center.

Examination commissions of Satbayev University check the work by the individual code of the entrant and send the results of the examination through the information system of National Testing Center for further publication of the results.

Authorized body in the field of education announces the results the day after the entrance exams through information system National Testing Center. The applicants can view the results of the entrance examination in the personal office on the day after the examination.

Based on the results of the entrance examination, an electronic certificate is issued and confirmed on the National Testing Center website.

After the completion of the entrance exams, National Testing Center performs an analysis of the CCTV recordings of the entrance exam.

In case the applicant is found to have used one of the prohibited subjects during the entrance examination, the results of the entrance examination shall be cancelled. Cancellation of results of competition on the award of the educational grant at the expense of the republican budget is carried out by the order of the authorized body in the field of education, during calendar year.

National Testing Center after completion of the entrance exam until August 25 of the calendar year shall review the video surveillance of the entrance exam.

In case of detection of the use of prohibited items by the applicant during the entrance exam, National Testing Center shall draw up the Act on detection of the use of prohibited items during the entrance exam and shall be sent to the authorized body in the field of education with the supporting materials. Then the results of the entrance exam, canceled by order of the authorized body in the field of education.

After the annulment of the results of the entrance examination, the Organization of Higher and Postgraduate Education shall send a notification to the applicants.

Persons entering the groups of educational programs of the fields of education "Natural Sciences, Mathematics and Statistics", "Information and Communication Technologies", "Engineering, Manufacturing and Construction Industries", as well as the areas of training "Business and Management" are exempt from entrance examinations to doctoral studies in the presence of an international certificate of passing the standardized test Graduate Record Examinations (GRE) with scores according to Annex 7 to this Regulation.

The authenticity and validity of the submitted certificates are checked by the Admission Committee.

6 Work of appeal commissions

6.1 Appeal commissions are established at the University to consider applications of persons entering the magistracy and doctoral studies who do not agree with the results of the entrance examinations.

The chairmen and composition of the appeal commissions shall be approved by the order of the Rector.

- 6.2 To consider the applications of persons who do not agree with the results of the Complex testing, the Republican Commission for The Consideration of Appeals under the Ministry of Education and Science of the Republic of Kazakhstan is created. The chairman and composition of the Republican Appeal Commission are approved by the order of the Ministry of Education and Science of the Republic of Kazakhstan.
- 6.3 The Appeal Commission accepts and considers applications from persons entering doctoral studies on the content of examination materials and technical reasons.

The Republican Appeal Commission considers applications from persons entering the magistracy on the content of test tasks and technical reasons.

- 6.4 The Appeal Commission and (or) the Republican Appeal Commission shall decide on the application of the person appealing the results of the entrance exam or Complex testing for groups of educational programs of postgraduate education.
- 6.5 An application for appeal from persons entering the doctoral program, master's degree is submitted to the chairman of the appeal commission by applicants personally or through the information system of the National Testing Center.

Applications are accepted until 13.00 hours the next day after the announcement of the results of the Complex testing and are considered by the appeal commission within one day from the date of submission of the application.

7 Admission rules for Master's and PhD at KazNRTU

- 7.1 Individuals are admitted at scientific and pedagogical master's with Kazakh or Russian language of instruction on a paid basis, this is based on results of CT in accordance with the 150-point grading system. See Appendix 8 to the given Rules: at least 50 points, English at least 25 points, according to the profile educational programs: choice of one correct answer at least 7 points, choice of one or more correct answers at least 7 points, according to the test to determine learning readiness.
- 7.2 Admission of individuals for PhD on a paid basis is carried out on the basis of an international certificate confirming proficiency in a foreign language in accordance with the common European competences (standards) of proficiency in a foreign language, the results of the entrance exam for the profile of the group of doctoral studies and who gained at least 50 points of possible 100.
- 7.3 The competition for training in scientific and pedagogical master's with the Kazakh or Russian language of instruction on the state educational order is available for individuals who have scored the highest scores in CT at least 75 points, English at least 25 points, according to the profile of the group of educational programs: choice of one correct answer at least 7 points, choice of one or several correct answers at least 7 points, according to the test to determine learning readiness at least 7 points.

The competition for training in a specialized master's with Kazakh or Russian language of instruction on a state educational order is available for individuals who have scored the highest scores in CT - at least 50 points, while in the profile of the group of educational programs: choice of one correct answer - at least 7 points, choice of one or more correct answers - at least 7 points, on the test to determine learning readiness - at least 7 points.

7.4 On a competitive basis, individuals who gained at least 75 points in the entrance exam are admitted for PhD on a state educational order.

Admission to master's and PhD is carried out in the following terms:

1) from 15 to 28 August of the calendar year;

2) from December 26 to January 10 of the calendar year.

In the case of the same exam results, the priority for admission to PhD is given to individuals who have the highest assessment of the entrance exam in the profile of the group of the educational program. Then, the points for the essay, the points for the test for learning readiness, scientific achievements corresponding to the profile of the educational program will be taken into account: scientific publications, including in rated scientific publications included in the 1, 2 quartile according to Journal Citation Reports of Web of science database Clarivate Analytics for the last 3 calendar years; certificates of scientific development; certificates of awarded scientific scholarships, grants; certificates / diplomas for participation in scientific conferences and competitions.

7.5 Untapped scholarships on the state educational order for PhD, including the target ones, are returned to the authorized bodies in the field of education in the form of an application for further redistribution between Organization of Higher and Postgraduate Education within groups of educational programs of postgraduate education until September 5 of the calendar year.

7.6 The University submits to the authorized bodies in the field of education within 10 calendar days a final report on the organization and conduct of admission, as well as copies of orders for admission to Master's and PhD on a state educational order.
